1	Local Plan	From Cllr Spencer – Following our decision at the PC meeting last night I am
		circulating a draft response to the current Local plan consultation. If you have any

		comments or amendments, please let me have them by 26th March; otherwise I will submit the response on behalf of Beachamwell Parish Council to meet the 1st April deadline. Although I personally have many concerns about the Local Plan in its current form, this response concentrates on the two aspects I raised last night concerning the policy dealing with development in villages without settlement
		boundaries(i. e. Beachamwell) - Policy HOU 05 Previously: It is a minor development of an appropriate scale and design to the settlement of up
		to 3 units.
		Now amended to:
		2. It is of an appropriate scale and design to the settlement. Response:
		The amendment is vague and imprecise, whereas the previous version had the merit of giving clear guidance, making it clear that any development should be of small scale only.
		The proposed wording is contrary to Paragraph 16(d) of the National Planning Policy Framework, which says that Local Plans "should contain policies that are clearly written and unambiguous, so it is evident how a decision maker should react to development proposals."
		Previously: It can be demonstrated that there is appropriate support by the parish council. Now deleted completely. Response:
		Whilst making planning consent dependent on the local parish council is probably is a step too far in passing over control of development from the local planning authority, nevertheless the principle of local community involvement in planning decisions is a good one. It is a mistake to remove this aspect of community approval and benefit completely from HOU 05. especially when Policy HOU 04, which deals with slightly larger village settlements, includes exactly this provision, as detailed at Paragraphs 3.22 and 3.23 where applicants for planning permission have to demonstrate community benefit and local support for their plans. It is inconsistent and unfair not to give the same benefit via HOU 05 to communities living in smaller villages.
		Cllr Lambert had proposed that Cllr Spencer replies on behalf of Beachamwell Parish Council, seconded by Cllr James and agreed by Cllrs Sanderson and Bridge.
